1. **Meeting called to order 7:00pm**: Tim Nink, president

- 2. **Secretary report Cari Draft**: Meeting minutes from October 3 reviewed; Motion and second to approve as written. Unanimously approved.
- 3. **Treasurer report Diana Holovka**: Diana reviewed her records for us. No questions; Motion & second to approve treasurer's report. Unanimously approved.
- 4. Correspondence
 - a. Emails: Tim noted one lady inquiring about memorial benches.
 - b. Mail correspondence: Diana reported no notable mail.
- 5. **Trail Manager Report** from **Muskegon County/Greg Sherburn via email to Tim**: Standard maintenance; port-a-jon at Broadway Trailhead will go in soon. Steve will be back on trail maintenance end of April.

Trail Manager Report from **Kate Alvarez/Ottawa County via email to Tim**: Ottawa County portion of the trail reconstruction has begun!

- 6. **Website & Facebook page:** Cari asked about updating the copyright footers; Tim took care of this after the meeting. Discussion to add Cari as an admin to the Facebook page; motion and second, unanimously approved. There is a website typo that needs to be corrected on FB.
- 7. **Current Expenditures/Reimbursement:** With our seasonal newsletter, we send out roughly 300 newsletters with donation envelopes. Diana mentioned donation envelope supply is running low. Gary made the motion to "pre-approve" Diana ordering new batch of donation envelopes when they run out; motion seconded and unanimously approved. Cost will be approx. \$345 for 2,000 envelopes.
- 8. **Brochure/trail map:**
 - a. Tim has more packs of our trail brochures if anyone sees a need anywhere!
 - b. Tim noted that **updated maps** will be needed because of construction & new membership pricing, mileage marker identification, etc.

9. **PROJECT LIST**

- a.) Current 2025 & beyond:
 - i. Web page & signage about Musketawa Trail rebuild in partnership with West Michigan Trails. On 4/22 Tim & Gary will meet with Jill (DNR) and John (WMT) about path forward for fund drive for trail rebuild "extras."

- ii. Annual spring cleanup of Broadway Trailhead scheduled date is April 19, 8am. (Cari) This usually takes between one and two hours; all help is appreciated. Cari created a save-the-date JPG, also see below. Tim & Cari will bring rakes, bags and gloves; Cari will bring treats, Tim/Sheri will bring perennial flowers to plant.
- iii. Caboose/Depot "Open House Days" will need volunteers to help Gary & Linda in Ravenna. Dates are on Saturdays June 7, July 12 & August 2, each day 9 AM to 1 PM.

b.) Future/longer term:

- i. Webpage and signage about Musketawa Trail rebuild in partnership with West Michigan Trails is in process and we have laminated posters for the trailhead kiosks. Yard signs to come.
- ii. Cari can revise her "Musketawa Farewell Cruise" event plan she presented at the August 2024 meeting to be a celebration of the new pavement. Ideas for a name: Pothole-Free Fiesta, Smooth Operator Ride or Asphalt Appreciation Ride. More discussion of promoting it as a family-style slow-roll type event. Plan will remain on "pause" until we know firm construction dates, most likely the ride will be Spring 2026.
- iii. Ed Holovka Memorial, to be located at the Muskegon/Broadway trail head. The most updated "shortfall" needed for the project to move forward is \$12,500.
 Jill Sell (DNR) recommends waiting until trail reconstruction happens to begin project.
 Also noted, more delays on trail reconstruction with more culvert replacements identified.
 Official reconstruction dates still unknown.
- iv. Last bike repair station to go along with Ed Holovka Memorial in Muskegon (purchased)
- 10. Gary and Linda gave summary of their participation of "Quiet Adventures Symposium" and "West Michigan Trails Summit" on March 6. Roughly 800 attendees at the symposium in Lansing; Gary & Linda reported this is well-worth our time and cost to be involved.
